

TERMS AND CONDITIONS

Dare to Learn is organized by Sivistyskiihdyttämö ry, a Finnish non-profit organization. This document sets out the terms and conditions between you and Sivistyskiihdyttämö ry when you purchase a ticket to Dare to Learn event. Sivistyskiihdyttämö ry reserves the right to change these terms and conditions at any time. Any updated Terms and Conditions will be posted on this website as soon as the updates have been finalized. This version of terms and conditions for Sivistyskiihdyttämö ry is applicable as of 2.3.2020.

Declaration of Consent

You give permission for Sivistyskiihdyttämö ry to collect, process and use all of the data you provide in Dare to Learn platforms. This information will be used for the purposes of processing ticket sales and creating attendee lists. The attendee lists can be used in sending information about the event and contacting attendees on behalf of the event. Names, email addresses, organizations and countries of residence will be added to our database. Tickets

Due to Sivistyskiihdyttämö being an association for the public good, all prices presented in www.daretolearn.fi are free of VAT. All tickets are non-refundable, but it is possible to reallocate the ticket to a third party 7 days prior to the event.

All tickets are personal and must be assigned to an attendee, and all required attendee details (full name and email address) must be given to organizers at least 7 days prior to the event. If you do not provide attendee information by that time, Sivistyskiihdyttämö ry reserves the right to provide an event badge to you.

The tickets are for your own personal use or that of your organization only and may not be re-sold or transferred for commercial gain under any circumstances. If there occurs any re-sale or attempted re-sale of any tickets (or any other breach of this term), we reserve the right to cancel the relevant tickets immediately without refund.

All payments must be made in euros. Admission to the event will not be given without full payment received prior to the event. Sivistyskiihdyttämö reserves the right to change the announced ticket prices. The applicable ticket prices are available on Dare to Learn website.

Cancellation policy

If the event is being cancelled due to unforeseen circumstances (force majeure), ticket holders will be refunded the price of the ticket against a valid receipt. Sivistyskiihdyttämö ry does not hold itself liable for any other expenses incurred. Sivistyskiihdyttämö ry attempts to inform its customers of force majeure cases as soon as possible.

Event Cancellation, Postponement and Substitution Policy

Sivistyskiihdyttämö ry is not responsible for any loss or damage of any kind incurred as a result of substitution, alteration, cancellation or postponement of an event. In the case of an unexpected incident independent of Sivistyskiihdyttämö ry, Sivistyskiihdyttämö ry reserves the right to make changes to the date and time for all parts of the event at least one week prior to the event. In the case of rescheduling of an event, the cardholder's ticket may be returned by a deadline determined by Sivistyskiihdyttämö ry. After the deadline has expired, Sivistyskiihdyttämö ry will not receive any claims for reimbursement. Sivistyskiihdyttämö ry reserves the right to make changes to the event at a date less than one week before, if there is a justified reason such as an unexpected problem with the location, or if a speaker is prevented from participating.

Please note that while speakers and workshop topics are confirmed at the time of publishing, circumstances beyond the control of the organizers may necessitate substitutions, alterations or cancellations of the speakers and/or topics. As such, Sivistyskiihdyttämö ry reserves the right to alter or modify the advertised speakers and/or topics if necessary without any liability to you whatsoever. Any substitutions or alterations will be updated on our web page as soon as possible.

Sivistyskiihdyttämö ry will not be liable for any loss, injury or damage to any person or property howsoever caused before, after or during the event.

Sivistyskiihdyttämö ry is not responsible for any lost or stolen tickets. Each participant must make provision for his or her own insurance.

Sivistyskiihdyttämö ry reserves the right to disallow access to the event for any behaviour, which it considers unacceptable.
